Overview of the role

The Senior Technical Project Manager leads the planning, execution, and delivery of complex technical projects, ensuring alignment with organisational goals and stakeholder requirements. This role coordinates cross-functional teams, manages project timelines and budgets, and mitigates risks to achieve successful outcomes. The post holder drives collaboration, continuous improvement, and innovation, ensuring compliance with relevant regulations and best practices. Strong leadership, communication, and problem-solving skills are essential for navigating technical challenges and delivering high-quality results in a dynamic environment.

Key responsibilities

- Work with business areas and ICT stakeholders to define the objectives, capabilities and benefits to be delivered by the project and ensure that priorities are in line with corporate objectives.
- Integrate and align the projects within the business environment to ensure overall change impact across ICT and the business is understood, managed and embedded, and informs effective stakeholder management.
- Create and develop long term and trusted partnerships with internal colleagues, customers and stakeholders by acting as the lead advocate, expert adviser, marketer and communicator for the projects assigned.
- Review progress, raise risks, assumptions, issues and dependencies and manage these successfully by presenting recommendations and agreeing how to resolve them.
- Own and be accountable for the principles, policies, processes and standards required to govern, prioritise, manage, assure, control and deliver the Project in line with the agreed gating methodology and governance arrangements ensuring that escalation rules are understood and adhered to.
- Manage overall time, scope and budget of the project ensuring that any additional requirements or opportunities are controlled and appropriately embedded within the existing project structure.

- Collate and analyse status and progress reports to the Project Board and make recommendations on actions required in areas of stakeholder and change management, risk, dependencies, cost vs benefits and resource conflicts.
- Ensure that the status of assigned projects are communicated effectively to ensure there is visibility of the project status to project and other board members and any other relevant and/or impacted stakeholders.
- Create, lead, motivate, develop and direct the project teams, including 3rd party stakeholders and build their reputation with the business. Lead and manage any escalations.
- To lead, motivate and manage all parties involved in the delivery and contribution to the project including 3rd party contractors. Act as the responsible owner to ensure that all council management considerations are addressed for and during their employment/engagement including in the case of 3rd parties/external organisations background checks, contractual obligations, financial due diligence, competence and capacity to undertake the work required.
- Responsible for identifying, validating, baselining, profiling, planning, tracking and reporting on benefit status of the project.
- Any additional duties consistent with the grade and level of responsibility of this position, for which the holder possesses the required experience and/or training.

Compliance
